1. X-Ray lab Technician:-

X-Ray Technology is used to produce diagnostically useful radiographic media .It requires Knowledge of Anatomy, Medical Law, Pathology, Patient Care,Physiology, Radiation Protection, Radiography, Radiology and Treatment. X-Ray Lab Technician uses their expertise and Knowledge to develop optimum radiological techniques and evaluate the resulting radiographic media.

However, the base responsibilities of the radiographer are summarised below:

- Autonomy as a professional
- Accountability as a professional
- Contribute to and participate in continuing professional development
- Enforcement of radiation protection (There is a duty of care to patients, colleagues and any lay persons that may be irradiated.)
- Justification of radiographic examinations.
- Patient care
- Production of diagnostic media
- Safe, efficient and correct use of diagnostic equipment
- Supervise students and assistant

2. Diploma in Medical Lab Technician:-

Diploma in medical laboratory technology (DMLT) is a medical lab technologist diploma course, Medical laboratory technology is the branch of medical science responsible for performing laboratory investigation relating to the diagnosis, treatment and prevention of disease. The main subject to be covered during the first and second of this course are the same as for degree course. Within completion of two year of the given course, the candidates after undergoing requisite course module, Diploma will be awarded and also have an option they continue if desired, the degree course within the requisite time schedule as mentioned in the course. The duration of the course. The duration of the course is generally two years but it depends mainly on the criteria prescribed in different institute in India.

3. O.T.Assistant:-

A Medical/O.T. Assistant is an allied health professional that supports the work of physicians and other health professionals, usually in a clinic setting. O.T. assistants can become certified through an accredited program usually offered through a junior or community college. They perform routine tasks and procedures such as measuring patient's vital sign, administering medications and injections, recording information in medical record keeping systems, preparing and handling medical instruments and supplies and collecting and preparing specimens of bodily fluids and tissues for laboratory testing. O.T. Assistant practices medicine and perform surgical procedures in collaboration with a physician.

4. Health sanitary Inspector:-

To impart technical training supplemented by practical training programme to candidate aspiring to join Health and Sanitation Departments of Municipal Bodies, District Councils, Railways, Five Star Hotels, Food and Drugs Administration, Airports or similar services in other organizations. To deal with Health and Sanitation problems including preventive health, family welfare, environmental conditions etc.

5. Dresser:-

A dressing is a sterile pad or compress applied to a wound to promote healing and protect the wound from further harm. A dressing is designed to be in direct contact with the wound, as distinguished from a bandage, which is most often used to hold a dressing in place. Modern dressings are self-adhesive. A dressing can have a number of purposes, depending on the types, severity and position of the wound, although all purposes are focused towards promoting recovery and protecting from further harm.

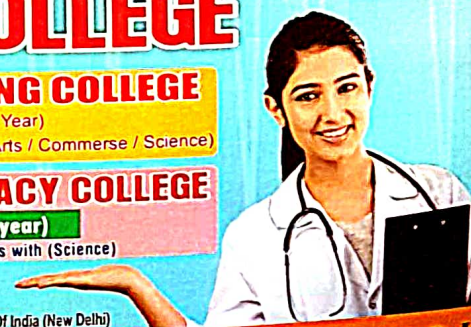
